**Officer Reports**

**Treasurer:** Kyle reported on the USA Swimming convention. He said they have given the bid for Western Zones to Redlands California. He also made note of the change USA Swimming has made regarding suits for 12 and under swimmers. In summary they cannot wear suits below the knee or past the shoulder. This new rule will go into effect in 2009.

Kyle also discussed the Long Course Championship and BC Finale expense reports as well as the costs from Zones.

Chanin would also like to remind the clubs to make sure the Meet Director is registered with USA Swimming.
